We carry the only device that measures alcohol levels every 7 minutes, 24 hours per day. Other devices may read alcohol levels, however, they do not report in real time.

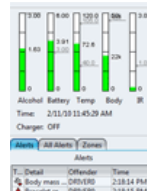

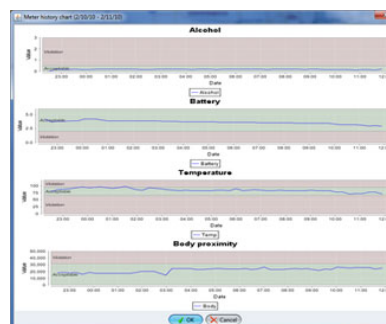
Bracelet detects traces of Ethanol based on alcohol consumption.
